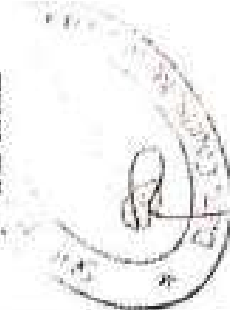

TRUST DEED

WHEREAS the Author is desirous of forming a Trust for the purpose of imparting education and has, for this purpose contributed a sum of Rs. 100,000/- (Rupees One Lakh only) towards the corpus of the Trust;

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The Name of the Trust shall be **MANAV VIKAS CHARITABLE TRUST.**
2. The Head Office of the Trust shall be situated at Plot no 27, Gali no 6, 100 Feet Road, Azad Nagar, Thanesar, Kurukshetra and the address may be changed as and when found necessary by the Trustees.
3. The area of operation of the Trust shall be the whole of India.
4. The objects of the Trust shall be any or all the following:
 - a. Advancement and propagation of education and learning including establishment, maintenance and support of school and other educational institutions.
 - b. To make provision to advance the cause of, and impart nursery, primary, secondary, higher, commercial, industrial, technical, physical and all or any other type or kind of education.
 - c. To establish, maintain, take over management, administer or run any institutions, colleges, university engaged in the imparting of education to students upto any level that may be found necessary and/or desirable.
 - d. To generally impart education to children and for the purpose to do all acts that may be necessary.
 - e. To establish, run, manage administer any institution or university or college or school to train persons to be teachers who will impart education to children and/or students in school, colleges, university and other similar institutions.
 - f. To establish, maintain, support and/or promote the spread of Vedic knowledge and practices, prayer halls, Yagya Shalas or through other organizations working in the field for raising moral and ethical standards and welfare of humanity in general without any distinction on the basis of caste, creed or religion;
 - g. To hold, arrange and organize meeting, lectures, talks, discussions, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, exhibitions, debates, cinema, audio-visual programme, the artistic performances and other cultural activities, sports and games.
 - h. Establishment, maintenance and support of libraries, museums and reading rooms and distribution of books etc., for advancement of education and knowledge in general.
 - i. To provide and meet all expenses of the School, colleges, university, and other educational institution.

- j. Advancement and propagation of education and learning including establishment, maintenance and support of Schools, Colleges, Universities, Pathashalas and other educational institutions, auditorium, professorship, lectureship, scholarship and prizes etc.
- k. Advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance during natural calamities and such other assistance as may be required from time to time provided
- l. To provide fees, books, equipments, freeships, and/or scholarships to deserving students.
- m. To feed poor students and to start student homes and hostels.
- n. To Promote women education and to run programs for creating awareness amongst women and spread the cause of women empowerment.
- o. To provide /assist in setting up laboratories.
- p. To make donation to other public charitable Trusts/institutions recognized under Section 80G of the Income Tax Act, 1961.
- q. To set up and operate schools/colleges.
- r. To conduct nutritional and health services.
- s. To conduct/operate program for providing nutritional assistance.
- t. To render assistance to poor patients by providing medicines etc., provisions of health care, preventive medical services (including dental services)
- u. Assistance to hospitals in setting up the various facilities such as Blood Bank, Eye Bank, Burn Centers etc. for poor students.
- v. Provision of outdoor dispensary or assistance thereof and also to run "Mobile" medical services.
- w. Conduct education in health care or provide assistance in the provision of primary health care education.
- x. To set up and run hospital/nursing homes/ Nature Cure Centers.
- y. To render assistance to the handicapped.
- z. To provide monetary assistance and social services in case of natural calamities.
- aa. To render financial assistance to the poor and the disadvantaged.
- Ab. To promote and advance moral education, youth character building/ formation camps, charity and general welfare of the people.
- Ac. To Organise Yoga and Ayurveda Training Programs Organization of Seminars, Conferences and lectures on the Subject especially Ayurvedic methods wherein contribution of professionals shall be elicited to enhance the level of capability of India as well as entire World
- Ad. Establishment of spiritual healing centers in India and abroad.

5. i) That none of the objects of this Trust shall at any time involve carrying on of any activity for profits;
- ii) That the income or the assets of the Trust fund shall not be applied or transferred in whole or in part for any purpose other than charitable and/or educational purpose;

- iii) That the income or assets of the Trust shall not be applied or used for the benefit of the authors of the Trust, or any person who makes substantial contribution or donations to the trust or any trustee or manager of this Trust.
- iv) That in the event of dissolution of the Trust the trust fund or surplus of the funds shall not be transferred to the trustees in any manner. However the same shall be transferred to a like minded trust duly approved by not less than 3/4 of trustees present at the meeting.

6. TRUSTEES

A) The first Trustees shall be :

1. Shri Chander Pal Singh S/o Sh. Manphool Singh R/o Gali no 6, Azad Nagar, Kurukshetra.
2. Shri Husan Pal Singh S/o Sh. Mohinder Singh R/o House no 03, Lane 1, Aggarsain Colony, Gharaunda Distt. Karnal.
3. Smt. Chander Kanta W/o Sh. Mahinder Singh R/o H.No. 14, Gali No. 1, Karan Vihar, Karnal.
4. Smt. Suresh Tanwar W/o Sh. C.P.Singh R/o Gali no 6, Azad Nagar, Kurukshetra.
5. Smt. Saroj Bala W/o Shri Husan Pal Singh R/o House no 03, Lane 1, Aggarsain Colony, Gharaunda Distt. Karnal.
6. Shri Chaman Singh S/o Sh. Prahlad Singh R/o Village and Post Office Bal Rangran Distt. Karnal.
7. Sh. Dharampal Rana S/o Sh. Jaldharth R/o VPO Bal Rangran, Distt. Karnal.

B) The number of Trustees shall at any time be Seven, however, the same may be increased by unanimous decision amongst the trustees.

C) The trustees mentioned at Sr. no 1 to 5 above shall be the life trustee and shall hold the office of the trust during their life time. After their demise any lineal legal heir of the above life trustee or any person nominated by him or her shall become the trustee in his/her place. In case the trustee above does not have any lineal legal heir the life trustees can co-opt any person as trustee in his/her place. The remaining trustees shall retire by rotation in one at time, the first to commence three years from the date of the trust deed. The retiring trustees will be eligible to be co-opted for further periods.

D) That subject to clause 6(C) above, A Trustee shall cease to hold office of the Trust on the Trustee becoming insane or lunatic,

- A) The management, control of the property and affairs of the Trust aforesaid shall be vested in the executive committee of the Trustees which shall be elected by the trustees after every three years, it shall include Seven office bearers i.e. Chairman, President, Secretary, Treasurer and Three Executive Member. The Following shall be the members of First Executive Committee :-

A	Sh. Chander Pal Singh	Chairman
B	Sh. Husan Pal Singh	President
C	Smt. Suroj Bala	Secretary
D	Smt. Suresh Tanwar	Treasurer
E	Smt. Chander Kanta	Executive Member
F	Sh. Chaman Singh	Executive Member
G	Sh. Dharampal Rana	Executive Member

The executive committee shall be vested with full powers and authority to purchase or hold any land or hereditament and construct any building for the object of the Trust or any fund or any other properties or investment at any time, subject to the Trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time to make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and not inconsistent with the provisions of section 2(15), 11 to 13 and 80-G of the Income Tax Act, 1961.

- B) The Executive Committee of Trustees shall meet as often as possible but not less than four times in a year and at least once in every calendar quarter for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.
- C) At least three Trustees or one third of the total number of Trustees for the time being (fraction being omitted) whichever be greater present within half an hour of the time fixed for the meeting shall form quorum; if no quorum be present even after expiry of half an hour, the meeting shall stand adjourned to such date, hour and place as may be fixed. When the meeting has been adjourned for want of quorum, notwithstanding anything stated above, the Trustees present at the adjourned meeting shall constitute quorum for the next meeting.
- D) The meetings of the Trustees shall be convened at such place in India and at such hour and on such date as may be agreed upon by the Trustees, or as fixed by the Chairman.
- E) All proceedings of the meeting of the Executive Committee of the Trustees shall be recorded in a Minutes Book kept for the purpose.

- F) Trustees who fail to attend four consecutive meetings without prior intimation or information shall cease to be Trustees, unless otherwise majority of other Trustees accord him exception on genuine and valid grounds.
- G) In the case of difference of opinion arising among the Trustees and in all matters wherein the Trustees have discretionary power, the votes of the majority of the Trustees for the time being shall prevail and be binding on the minority as well as on those Trustees who may not have remained present or voted. In case the Trustees are equally divided in opinion, the matter shall be decided according to the casting vote of the Chairman.
- H) It shall be lawful for Trustees to pass resolutions, postal or other communications and such resolutions, shall be called "circular resolutions".
- I) That if any of the Trustees either original or appointed under these presents in pursuance of the provision hereinbefore contained shall die or be desirous of being relieved or refuse to act or become unfit or incapable to act in the duties and powers reposed in him or hereunder these presents or be declared insolvent or convicted of a criminal offence involving moral turpitude, he or she shall cease to be a Trustee, and thereupon a vacancy shall be deemed to have arisen among the Trustees, and then and so often as the same shall happen, it shall be competent for the continuing or surviving Trustee or Trustees in his or her place. It shall be also competent for the Trustees for the time being of these presents from time to time to appoint new exceeding and the provisions made hereinabove are observed. The absolute consensus amongst the trustees are required to remove any Trustee from the office of Trusteeship of the Trust and upon such removal he shall be bound to vacate the office of trusteeship and hand over the property or records of the Trust to the remaining Trustees.
- J) The Executive Committee may appoint committees and/or sub-committees and may delegate to them or to the office bearers of the Executive Committee or any of them, from time to time, such of its powers, as the Executive Committee may deem proper or expedient.

7. THE CHAIRMAN OF THE EXECUTIVE COMMITTEE SHALL

- a) To preside over all the meetings and to sign and confirm the proceedings.
- b) In the absence of the Chairman the meeting will be presided over by a member so elected to preside in that meeting.
- c) Look after the properties of the Trust jointly with President;

d) Be authorised to collect subscription and donations etc., and to issue receipts for the same.

e) Supervise the income and expenditure of the Trust jointly with president.
THE PRESIDENT OF THE EXECUTIVE COMMITTEE SHALL,

a) Conduct correspondences on behalf of the Trust;

b) Look after the properties of the Trust jointly with Chairman;

c) Supervise the income and expenditure of the Trust jointly with Chairman;

d) Be authorised to collect subscription and donations etc., and to issue receipts for the same.

e) Sanction payments of the bills.

f) To incur expenses and make payments on behalf of the Trust.

g) Sign all papers on behalf of the Trust and in the name of the Trust.

h) Conduct legal proceedings, institute suits or other legal proceedings, defend legal proceedings on behalf of the Trust and shall be entitled to sign and verify the plaints, written statements, applications or other pleadings on behalf of the Trust and give instructions. He shall not be entitled to compromise, compound or withdraw any matter of proceedings without the previous sanction of the Executive Committee.

i) Arrange for, supervise and manage all functions discourses, performance and for that purpose give permission to others to use the premises of the Trust.

j) To manage the immovable properties belonging to the Trust to induct and eject the tenants, leases, etc., to receive rent or lease money from them;

k) And generally do all such things and acts which are necessary to carry out the objects of the Trust and which are in the interest of the Trust.

9 **THE SECRETARY OF THE EXECUTIVE COMMITTEE SHALL**

i) To convene the meetings of the General body and the Managing Committee, to attend and record all proceeding of such meetings in the Minutes Book.

ii) To carry on the correspondence of the Institution and to maintain its Books, Accounts and Registers.

- iii) To receive and distribute money on behalf of the Institution under orders of the Managing Committee,
- iv) To present yearly report of the working of the Institution in an annual meeting.
- v) To produce records to the official/officers and members of the Board.
- vi) The secretary will send the certified true copies of all the proceedings to the Board for information.
- vii) Any change in the office bearers, validly made according to the rules, shall be intimated to the Board from time to time.

10. THE TREASURER OF THE EXECUTIVE COMMITTEE SHALL

- a) To maintain accurate accounts of the cash and stock of the Institution.
- b) All the maintenance of the Bank Account.

11. POWER OF TRUSTEES

- A) To manage Trust funds and collect and recover the interest, income and profits thereof and to pay there out the expenses of collection and other outgoing, if any.
- B) The Trustees shall have all powers specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of the Trust, whenever, such powers are not specifically conferred.
- C) The Trustees shall be entitled from time to time to open, maintain and operate a Bank account or accounts in the name of the Trust or in the name of the School or Schools or College(s) or University or Institutions at such Bank or Banks as they from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trust Fund/School Fund/College Fund/University Fund or the income thereof to the credit of any such account or accounts either by way of Fixed or Current/saving Account or any other account. Any such account shall be operated upon jointly by any two out of Chairman or President or Secretary or Treasurer or such other person as authorised by the managing committee.
- D) The Trustees are bound by all the liabilities cast upon them under the Indian Trusts Act, 1882 except to the extent of the powers specifically conferred under these presents.

- E) The Trustees at their discretion may sell any immovable property or properties which may for the time being the subject of the Trust of these presents, with power to buy and sell the same without being responsible for any loss that may thereby be incurred and in case of such sale, to execute and do all such deeds and act for the purpose of carrying such sales into effect as the Trustees may think necessary and all monies accruing from any such sale shall be deemed to be part of the Trust Estate and shall be applied accordingly.
- F) The Trustees may at any time receive voluntary contributions from any person or persons by donation, legacy, gift, annual or monthly subscription for the benefit of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.
- G) Proper accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Trustees who shall prepare Receipts and Payment Account, Income and Expenditure Account and Balance Sheet as on March 31st every year and shall be duly audited by a qualified Chartered Accountant.
- H) The Trustees may appoint regular, permanent, part time or honorary staff if necessary according to the requirement for the managing or working of the Trust and use the Trust Funds for payment of their salaries, compensation or expenses, etc.
- I) The Trustees shall have power to raise or borrow for the purposes of Trust from time to time in the name of the Trust or otherwise on behalf of the Trust such sums of money as they may from time to time deem expedient from any bank/financial institution, person, firm, trust or society either on the mortgage of the whole or any part of the property of the Trust, or by bonds, debentures, deposit receipts, promissory notes, with or without security or in such other manner as they may consider proper.
- J) All the funds of the Trust shall be dealt with under section 13 of the Income Tax Act of 1961.
- K) The Trustees may reimburse themselves and pay and discharge out of the trust funds all expenses incurred by them in or about the execution of the Trust or in exercise of powers conferred under these presents.
- L) It will be lawful for the Trustees to delegate any of their powers for limited purposes of management to any one or more of the trustees jointly and/or severally, and if necessary to cancel or modify the same.

The Trustees shall be entitled to authorise by a resolution any one or more of the Trustees or any other person or persons jointly or severally to

receive money payable to the Trust and to pass receipts for the same, and such receipts shall discharge the person or persons making the payments without they being bound to see to the application thereof and without they being liable or answerable for loss or misapplication thereof.

- N) The Trustees shall also be entitled to take over the management of any other Trust or Societies or Institutions as well as carry out the trust under any deed or Trusts for religious and or charitable purposes set out hereinafter on such terms and conditions as may be thought fit by them in their absolute discretion provided that they are not inconsistent with the terms hereof or the objects of the Trust set out in this Trust Deed.
- O) The Trustees shall have powers to amalgamate with and/or take over other Trust or Trusts having wholly public charitable objects.

12. DUTIES & OBLIGATIONS OF THE TRUSTEES:

- i) The Trustees will manage the subject-matter of the Trust and take decisions regarding the matter of policies concerning the fulfillment of its objects as the majority of Trustees may decide.
- ii) The Trustees shall, out of the income of the Trust in the first instance, pay all management charges, cost, expenses and salaries etc. and other expenses incidental to the management and the administration of the Trust, its properties and assets, and shall utilize the net income for the charitable objects aforesaid in the best possible manner in accordance with the objects of the Trust.
- iii) Any Trust property held in the name of outgoing or dead Trustee shall automatically stand transferred with all convenient dispatch from his name to the surviving trustees. Upon every appointment of new Trustee or Trustees as laid down below, the trust property and other funds shall, if and so far as the nature of the property and other circumstances shall require or admit or, Trustees for the time being, and every Trustee so appointed as aforesaid may, before as well as after, such transfer of the property, act and assist in the execution of the Trust and exercise of powers under these presents as fully and effectually as if he had been appointed under these presents.
- iv) The Trustees shall be respectively answerable only for such moneys or securities or other property as they shall respectively actually receive notwithstanding their signing any receipt for the sake of conformity or advance receipt and shall respectively be so answerable and accountable only for their own respective acts, receipts, omissions, neglects and defaults and not for those of each other or for any banker, broker, auctioneer or other persons with whom or into whose hands any Trust

13. The Trustees shall have power to keep invested the Trust Funds in suitable avenues keeping in view the safety of the investment, including movable and immovable properties, shares, deposits in banks, debentures, government securities and loans, stocks, deposits with post office and other government institutions, in conformity with the provisions of the income tax act and other laws.

PROVIDED ALWAYS that the Trustees shall have power to sell, convert or vary the said investments into investments of the same or other kind or nature authorized by these presents or to sell, convert or realize the said investment or investments into money.

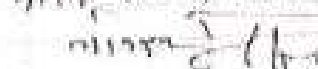
14. All securities and other funds of the Trust may be kept in the names of any two or more of the Trustees or be made payable to or transferable by any two or more Trustees or be transferred in the name of any bank, on the said bank agreeing to hold the same for and on behalf of the trust, or deposited for safe custody with a bank with authority to collect, scripts and receipts shall be credited in a current/saving account maintained with the said bank, and the said current/saving account shall be operated by cheques signed by the Trustees who may from time to time be authorized in this behalf.

15. In the event of the dissolution or the winding up of the Trust, the assets remaining on the dissolution shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust and that in no event shall the assets so remaining be distributed among the Trustees.

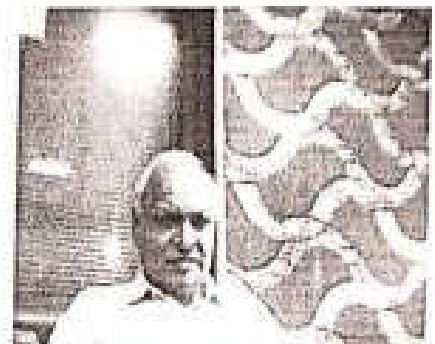
